



## **Protocol on Detailed Agenda**

On 28 May 1991 the delegation of the Government of the Republic of Mozambique, headed by Armando Emílio Guebuza, Minister of Transport and Communications and composed of Teodato Hunguana, Minister of Labour, Aguiar Mazula, Minister of State Administration, and Francisco Madeira, Diplomatic Adviser to the President of the Republic, and the RENAMO delegation, headed by Raul Manuel Domingos, Chief of Foreign Relations Department and composed of Vicente Zacarias Ululu, Chief of the Information Department, Anselmo Victor, Chief of the Political Affairs Department, Agostinho Semende Murrial, Deputy Chief of the Political Affairs Department, João Francisco Almirante, member of the President's Office, met at Rome in the San Egidio Community Headquarters, in the presence of the mediators, Jaime Goncalves, Archbishop of Beira, Andrea Riccardi and Matteo Zuppi of the Community of San Egidio.

Based on the proposal presented by the mediators, the two parties agreed on the details of the agenda approved on 10 November 1990 as follows:

1. Political Parties Act
  - a) Criteria and arrangements for the formation and recognition of political parties.
2. Electoral Act
  - a) Freedom of the press and access to the media.
  - b) Freedom of association, expression and political communication.
  - c) Freedom of movement and residence.
  - d) Return of Mozambican refugees and displaced people and their social reintegration.
  - e) Electoral Procedures: a democratic, impartial and pluralistic voting system.
  - f) Guarantees for the electoral process and role of international observers.
3. Military questions
  - a) A non-party national army: criteria for its formation, composition and size.
  - b) Withdrawal of foreign troops from Mozambican territory.
  - c) Activities of private and irregular armed groups.
  - d) Functioning of the SNASP.
  - e) Depoliticization and restructuring of the police forces.
  - f) Economic and Social reintegration of demobilized soldiers.
4. Cease-fire
  - a) Arrangements for the cease-fire and the freeing of prisoners, except for those being held for ordinary crimes.
  - b) Organs and arrangements for observing, supervising and controlling the cease-fire and international role in the process.
  - c) Operational timetable for the cease-fire.

5. Guarantees
  - a) Timetable for the conduct of the electoral process.
  - b) Politico-Military Commission to supervise the cease-fire and monitor respect for and implementation of the agreements between the parties within the framework of these negotiations; its compositions and powers.
  - c) Specific guarantees for the period from the cease-fire to the holding of the elections.
6. Donors' conference
  - a) Organisation of a conference of donor countries to finance the electoral process and emergency programmes for reintegrating the displaced and refugee population.
7. Signature of the agreed documents and the final Protocol.
